Powder alkaline detergent with very high causticity

→ DESCRIPTION

Removil is a powder alkaline formulation with very high causticity and high wetting and sequestering ability, suitable for the cleaning of strong dirt in all sectors of the alimentary industry and beverage bottling.

Removil is able to easily remove strong tartrate residues in the oenological industry and can be used for the washing of bottles and kegs in the sector of beverages in general. The presence of controllers of the water hardness enables to work also with average hard waters, preventing the deposit of limestone. **Removil** can also be used in sectors where the presence of strong contaminations requires a particular washing ability, such as the cleaning of industrial fryers and kettles and the dairy industry.

→ INSTRUCTIONS FOR USE*

Use **Removil** at variable concentrations between 0,5 and 8%, according to the kind and degree of the contamination. We suggest temperatures above 50°C. Final rinsing with drinking water till any possible residue of detergent is completely eliminated.

-> FIELDS OF APPLICATION

For the alkaline washing of closed circuits, tanks and pipes, CIP plants, heat exchangers (pasteurizers, skimmers, evaporators).

For the alkaline washing of vats and wine tanks. For the washing of bottles and kegs.

-> COMPATIBILITY OF THE FORMULATION

Removil is compatible with most material normally present in food industries, if used according to the producer's indications. Do not use on aluminium, copper, zinc-plated iron and surfaces treated with phenolic resins. In case of doubt, carry out a test on the single material before using the product.

-> PRECAUTIONS FOR HANDLING AND STORAGE

Store the formulation far from extreme temperatures. Consult the Material Safety Data Sheet.

-> TITRATION METHOD

Sample: 50 mL of washing solution

Indicator: phenolphthalein

Titrating agent: hydrochloric acid (HCI) 1N

% (v/v) **Removil** = mL titrating agent x 0,101 % (w/w) **Removil** = mL titrating agent x 0,083

→ PACKAGING

1 kg net packs in cartons containing 20 kg. 25 kg net bags.
