→ DESCRIPTION

The presence of controllers of the water hardness enables to work even with waters with an average hardness. In order to optimize the results of washing cycles, we suggest a following descaling acid phase, with a periodicity to be estimated.

→ INSTRUCTIONS FOR USE

After a first rinsing with water, apply a solution of **Alca 30 Plus** at variable concentrations from 0,5 to 3,0%. We suggest temperatures above 50°C. Final rinsing with drinking water till any possible residue of detergent is completely eliminated.

→ FIELDS OF APPLICATION

For the alkaline washing of closed circuits, tanks and pipes, CIP plants, heat exchangers (pasteurizers, skimmers, evaporators).

For the alkaline washing in washing tunnels and/or by immersion for moulds, trays and different containers.
