→ DESCRIPTION

Sintodry FG is a liquid lubricant for conveyor belts for the transport of plastic (PET) and poly-coupled carton (TETRA) containers for liquid products, glass and cans, to be exclusively used for plastic conveyor belts in the food, cosmetic and pharmaceutical sector.

Sintodry FG is homologated NSF H1 (registration no. 159487) for incidental contact with food and beverages.

Sintodry FG is supplied in a non-diluted form with even very long intervals (1-3 hours) between a spraying and the next one.

Sintodry FG is no foaming and enables to completely eliminate the water consumption, sensibly reducing operating costs.

Sintodry FG is supplied with the help of suitably structured centralized systems (Lubimatic Control Dry). For further details, please refer to the specific documentation.

→ INSTRUCTIONS FOR USE

The supply of **Sintodry FG** is carried out without dilution with the help of high precision centralized equipments, such as Lubimatic Control Dry, by dividing the equipment into different areas in the case or particularly long or complex lines and by utilizing nozzles with a fan spraying. The spraying frequency depends on the running speed of the lines. The compatibility with the packaging materials should be tested before the formulation is applied.

→ COMPATIBILITY OF THE FORMULATION

Sintodry FG is compatible with most material normally present in food, cosmetic and pharmaceutical industries, if used according to the producer's indications. In case of doubt, carry out a test on the single material before using the product.

Sintodry FG is scarcely compatible with traditional lubricants (soaps and amines), so it is suggested to wash the lines before applying it.

→ PRECAUTIONS FOR HANDLING AND STORAGE

Store in the original containers and avoid extreme temperatures. Consult the Material Safety Data Sheet.
